Proof of Personal and Property Liability Insurance for Tow Trucks
You must submit a copy of the Insurance Certificate for your tow trucks. Your Insurance Certificate for your tow trucks.

You must submit a copy of the Insurance Certificate for your tow trucks. Your Insurance Certificate must name the City of New York as the certificate holder. Minimum amounts of coverage are:

- \$300,000 for personal injury or death of any one person or because of injury or destruction of property of others resulting from any one accident
- \$500,000 for personal injury or death of two or more persons resulting from any one accident
- \$25,000 for damage to a vehicle in the care, custody, and control of the tow company

<sup>\*</sup>If you are applying for the license within three to six months prior to the end of the license period, you can pay the prorated fee for the license period about to end plus the fee for the new license period. If you pay both fees, you will not need to renew the license until the end of the next license period.
