Dear Provider:

We want to make you aware of the vaccine codes for the flu vaccines that are available for the 2025–2026 season. Please share this notice and the attached table with your billing and technology staff and any billing system or electronic health record (EHR) vendor so that your system's vaccine codes can be updated. Regularly updating your system will enable you to report vaccines correctly to the Citywide Immunization Registry (CIR).

If you are reporting immunizations directly from your EHR via the CIR HL7 Web Service, reach out to your EHR vendor or onsite technical contact for assistance reporting sale NDC11 to the CIR and note the following:

1. When reporting NDC for an immunization administered, you must report the **sale NDC11 value**, which can be found on the vaccine box. For example, a dose of Fluzone Trivalent, preservative-free (2025/2026 flu season, CVX 140) would be reported with **sale NDC11 value 49281-0425-50** (as opposed to the NDC11 value of 49281-0425-88).
2. Report CVX codes with NDC codes if possible.

Please take this opportunity to review all your vaccine codes and check for miscoding errors. Refer to the CDC NDC Crosswalk Tables, CVX, CPT Vaccine Code Sets [here](#).

Note that if you have already purchased any multidose influenza formulations, doses from multidose vials should only be used in children  $\geq 3$  years of age, or in children 6–35 months of age if there is no other available product when the child presents and consent has been given. Refer to the **Seasonal Flu Vaccination Kick-Off** letter, which will be available [here](#).
