Notes from Frances Pardus-Abbadessa, Executive Deputy Commissioner HRA/OCSE:

OCSS Collected \$48.7 million for the month of July, averaging \$12.2 million per week. Total calendar year to date collections (Jan-Jul) have reached \$388.3m which is a 0.61% decrease over the same period in 2024. Paternity Establishment Percentage (PEP) remains high reaching 77.65% and Support Establishment Percentage (SEP) remains stable at 73.24%. Cases with a collection in the month (which includes actively charging and arrears only cases) remains steady at 41.72%, but if we consider only actively charging cases with an ongoing obligation, 59.53% received a payment.
