## Notes from Frances Pardus-Abbadessa, Executive Deputy Commissioner HRA/OCSE:

OCSS Collected \$62.2 million for the month of August, averaging \$12.4 million per week. Total calendar year to date collections (Jan-Aug) have reached \$450.5m which is a 0.43% decrease over the same period in 2024. Paternity Establishment Percentage (PEP) remains high reaching 77.33% and Support Establishment Percentage (SEP) remains stable at 72.93%. Cases with a collection in the month (which includes actively charging and arrears only cases) remains steady at 43.01%, but if we consider only actively charging cases with an ongoing obligation, 59.55% received a payment.
