of Information Technology and
Telecommunications Calendar Item No. 1:
In the matter of the intent to seek
Franchise and Concession Review Committee
review relating to a proposed change of
control of a cable television franchise
held by Cablevision Systems New York City
Corporation, or Cablevision, in Brooklyn,
whereby Cablevision will be ultimately
controlled in majority by Altice NV and
its parent entities.

MR. HATCH: Does anyone wish to
testify?

MS. RUIZ: Bethsy Morales-Reid.

MS. MORALES-REID: Thank you. On
behalf of the Hispanic Federation, I
appreciate the opportunity to weigh in on
the proposed Cablevision/Altice
transaction. The Hispanic Federation is a
network of Latino-serving non-profit
agencies that serve the most vulnerable
members of our community. We advocate

nationally on vital issues including education, health, immigration, economic empowerment, civic engagement, and environment.

As a national advocacy organization, the Hispanic Federation has been a proud partner with Cablevision and a benefactor of its charitable support for the Hispanic community. Cablevision is a strong community partner and a great corporate citizen; a partner that does not only focus on its products and services, but gives back to our community in substantive ways. The community has been open to using -- I'm sorry, the Company has been opened to using its programming assets, production capabilities, and charitable generosity to support our member organizations and the important support services they provide to the two million Latinos in New York-Metro area.

Specifically, Cablevision has hosted televised Town Hall events, produced entirely in Spanish, to deliver important

news reporting to the Hispanic community. They have also produced Public Service Announcements, which provide important marketing support for our member non-profit groups, and have also aired documentaries in Cablevision's local programming stations that tell the story of Latino immigration in New York.

In the programming arena, Cablevision has worked to ensure that the diverse Hispanic communities in New York City have access to exclusive Spanish-language programming. The current package, with over 55 channels, feature in-language networks from Latin America, South America, the Caribbean, Spain, Puerto Rico, Dominican Republic, and Mexico, as well as unlimited use of World Picks Latino on Demand, a unique Spanish-language Video on Demand service. In addition to the Spanish-language package channels, Cablevision also carries popular channels like Univision, Galavision, Telemundo, Estrella, Exitos

TV, Mundo Fox, UniMAS, Vme, HBO Latino, and a robust offering of Spanish-language Movies on Demand.

I'm pleased that a company like Altice, a strong global communications company with operations in eight countries, including the Dominican Republic, has chosen to make New York the base of its US operations. Altice is expected to bring a fresh perspective based on its experience in diverse, highly competitive markets around the world. We at the Hispanic Federation look forward to learning more about the company's planned commitments to investments in networks, service innovation, and high quality local, national, and international content. We also understand that the company is well resourced and we are optimistic that they will continue Cablevision's long-standing tradition of generosity to community organizations.

Finally, Cablevision is known for attracting and retaining a diverse and

MS. CHAPMAN: Good afternoon, committee and guests. My name is Melissa Chapman and I serve as the Senior Vice President for Public Affairs at the Brooklyn Chamber of Commerce. This testimony is being delivered on behalf of our President and CEO, Carlo Scissura.

The Brooklyn Chamber of Commerce is a

membership-based, business assistance organization that represents the interests of over 2,200 member businesses, as well as other businesses across the borough of Brooklyn. The Brooklyn Alliance is a not-for-profit, economic development organization of the Brooklyn Chamber, which works to address the needs of businesses through direct assistance programs.

We're here today to express our support for the proposed change of control, whereby Cablevision will be ultimately controlled in majority part by Altice NV and its parent entities. As the voice of the Brooklyn business community, we believe our members and local economy will benefit from the enhanced competition and innovation that will result from this transaction.

Economic growth is reliant upon a world class infrastructure system that prioritizes connectivity and broadband accessibility. Cablevision's long history

BRIC is the leading presenter of free cultural programming in Brooklyn and is honored to serve as the community access organization for the borough. BRIC is dedicated to amplifying and enabling diverse artistic and community voices, and to sustaining community through arts and media. We are deeply grateful for the long-standing support of our work by Mayor de Blasio, Borough President Eric Adams, and Comptroller Scott Stringer. It is this support that makes our work in community media and in the arts possible.

We thank the members of the Franchise and Concession Review Committee for holding this hearing to consider the proposed Cablevision/Altice merger. These hearings are of vital importance for all of New York City.

Cablevision provides major meaningful support to BRIC's work to bridge the digital divide through vital education programs, to enable community voices, to amplify the work of Brooklyn non-profits,

and to shine a spotlight on matters of concern and interest to Brooklynites. Brooklyn is greatly served by that work and it is vital the work continue.

Our grant agreement with Cablevision helps us bridge the digital divide through classes taken by more than 5,000 adults yearly, and through classes offered at dozens of public schools where we teach thousands of students every school year.

BRIC's television studios, location equipment, media lab, and edit suites are all offered free of charge to Brooklyn residents and community organizations to create their own media. We are open seven days a week to accommodate the schedules of working-class people and students.

To enable us to reach individuals through our borough of two-and-a-half million people, and with Cablevision's support, BRIC has formed an important partnership with the Brooklyn Public Library, and thus is able to offer convenient video and social media classes

at library branches across the borough.

Our new BRIC TV initiatives provides vital, hyper-hyper local, in-depth media coverage of Brooklyn neighborhoods, issues, culture, and people; coverage which is otherwise entirely absent from the landscape. Over 2,000 Brooklyn-based guests have appeared on our live daily show, and our BRIC TV Civic Affairs programming highlights civic events, live debates, and interviews with local elected officials.

BRIC also provides media capacity building services to under-resourced non-profits. For example, through BRICs Media Share program, we offer non-profits in the borough in-kind grants to create video to advance their work.

New York City's public access community will be well-served by this merger if Altice commits to continue Cablevision's work, most specifically by providing stable financial support for Public Access services regardless of any

For several years Cablevision's Optimum Community program has hosted an annual summer reading event with NBA great, John Starks, at a BPL branch, most recently Coney Island Library. Optimum Community's Neighborhood Journal has raised awareness of library initiatives with coverage of our summer reading kick-off, Brooklyn Cultural Adventures program, and the annual Brooklyn Classic Fundraiser.

We are pleased that Altice, with its experience, resources, and history of innovation, will be our new partner. We believe that company will continue to invest in Brooklyn with broadband infrastructure and community programming. Thank you.

MS. RUIZ: Bob Master.

MR. MASTER: Good afternoon. My name is Bob Master, I'm Assistant to the Vice President for CWA District 1, which represents 30,000 workers who live and work in New York City, and 140,000 public and private sector workers from New Jersey to Maine. Thank you for the opportunity to speak to you today.

The Communications Workers of America is pleased to endorse the sale of Cablevision to Altice, and we urge the Committee to approve the transfer of the

franchise between the two companies today.
We believe that this transaction is in the
best interest of both New York City
telecommunications consumers and the 250
workers we represent at Cablevision's
operations in Brooklyn.

As most of you know, the course of
labor management relations over the last
four years in Brooklyn has been, shall we
say, less than smooth. Therefore, we are
very pleased to inform you that CWA and
Altice have negotiated an extension of the
current collective bargaining agreement
that guarantees three years of job
stability and includes several significant
improvements in wages and contract
language. In addition, the agreement,
which will take effect upon completion of
the Cablevision/Altice sale, includes a
resolution of all outstanding legal issues
between the parties, including several
ongoing National Labor Relations Board
proceedings.

We believe that thanks to cooperative

Proceedings

approach taken by Altice, we have turned the page on the labor relations challenges of the past in Brooklyn Cablevision, and have good reason to hope that a new day has begun. Parallel to the negotiations with CWA, Altice has engaged in dialog with the City of New York about its public interest commitments. We believe that DoITT and the City have done an excellent job ensuring that the needs of New York City's cable consumers in Brooklyn and the Bronx are being protected. In short, this deal is good for all New Yorkers.

In light of this, we support the most expeditious resolution of the transaction, and we believe once the Public Service Commission completes its review of the sale, and imposes whatever conditions it chooses to impose, the transaction should close.

In closing, let me reiterate the support of the CWA for the Cablevision/Altice transaction today. We urge you to approve the deal. Thank you

It's simply the job of the Department -- DoITT -- I always switch your T's -- it's really critically important for DoITT to exercise the over site to ensure that our residents are treated equitably. Remember that both in terms of Brooklyn and the Bronx, these are both areas in which we are actively and aggressively pursuing compliance of Verizon over the commitments it made to the City to serve low-income residents. We are simply trying to ensure that since there's not sufficient competition as of yet, we're still working on Verizon, that to the extent Cablevision, and now Altice, will step into its role, that DoITT can ensure

MS. GIORDANO: Good afternoon. I'm Alice Marie Giordano from the Academy of Mount St. Ursula, a catholic high school for young women in the Bronx. Thank you for this opportunity.

Conducted in the Ursulan tradition, our schools serve college-bound women of diverse cultures by instilling a love of learning and a broader global view. In a family atmosphere, we strive to empower young women for leadership in society.

I'm here today in support of the proposed acquisition of Cablevision by Altice because I believe that this transaction will allow our valued relationship with Cablevision to continue and thrive for many years to come. Our school has enjoyed a strong partnership with Cablevision for many years. Through Cablevision's Optimum Community program, the Academy of Mount St. Ursula students have participated in Charity Champions for several years. This program has fostered school spirit, inspired and supported charitable work for our young women, and benefited many local charities. MR. KNOBBE: BronxNet, a community media network serving the people of the Bronx, thanks the New York City Franchise and Concession Review Committee for

holding these important hearings.

Hello. I'm Michael Max Knobbe,
Executive Director of BronxNet. We are
the not-for-profit network providing
public services including access to
technology, studios, and channels with
workforce development opportunities for
high school and college students.
BronxNet televises diverse award-winning
programs across a spectrum of media,
including six cable television channels
that help connect one of the diverse
counties in the nation to the world.

We ask that Altice not only be asked
to adhere to the current agreements in
place with BronxNet and other community
access organizations serving the City, but
also to express their view on continued
and expanded support for BronxNet beyond
the current agreements, including plans
for subscriber-based and capital support,
as well as technological growth that keeps
pace with the times in terms of channel
delivery.

It is imperative that community media channels not be left behind, but be transmitted in High Definition, which is at least equitable with the broadcast TV resolutions of the times. By June, BronxNet will have the ability to add all of its channels to our existing digital MPG2 transport stream transmission. If the headend -- if the Cablevision headend remains status quo, the signals for our channels would be regrettably down converted prior to encode to the headend, and we are an HD native facility. HD is the quality that viewers have come to expect and it is important that our channels are televised through High Definition.

Through BronxNet's public access facilities, we train the public in media production by providing television, studio, and field production workshops, and enabling access to technology, as well as the acquisition of valuable workforce development skills. People completing the

Proceedings

training can utilize media production equipment at no cost to produce programs and share diverse, ultra-local content that contributes to community development through media. It is important to consider how media literacy, access to broadband and technology, along with the related skills, are increasingly more essential for participation in contemporary civic and economic life, and BronxNet is an anchor institution serving a vital role in the technology future of the Bronx and this great city.

As times and technology change, BronxNet works to stay leading edge as we enhance our public services in the Bronx. We promote media literacy and we're continually upgrading our production equipment to help Bronxites keep pace and access technology that might otherwise be out of reach. We've trained over 3,000 high school and college students in media production, and we've trained thousands more members of the public. With the

Proceedings

opening of our new media production facility in the East Bronx at Mercy College at the Hutch-Metro Center, and with planned upgrades to our network operations at Lehman College via capital allocations from Bronx Borough President Ruben Diaz, Jr., and the City of New York, we are creating more venues, including studios equipped with the latest technology, and other places of assembly where Bronx residents can create unique programs including those with live community audiences.

BronxNet is producing more programs in partnership with the organizations that serve our borough resulting in educational content that strengthens civic participation. One example is the Viewer Voter Guide that we do with the non-partisan organization, New York City Votes.

Since its inception, BronxNet has collaborated closely with high schools and institutions of higher learning. The

people we serve include a cross-section of the very diverse population of our borough. Civic, knowledge industry, creative economy, and human services, the agencies and institutions seeking to communication with the borough, region, and the world, rely on our channels and services, and we help to build a thriving public access media network with our neighbors where people work together and utilize this vehicle of free speech positively to improve outcomes and effect workforce and community development.

We thank New York City for supporting community media and the Mayor and the Commissioners. We look forward to partnering with Altice, should the sale go through. Many positive results have come out of our relationship of over two decades with Cablevision. We ask that Altice work with BronxNet in the scope of transfer to plan for the continuation and enhancement of the vital public services that BronxNet provides for the benefit of
