**No. 1:**        **IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval pursuant to Section 1-16 of the Concession Rules of the City of New York, to utilize a different procedure, to enter into a Sole Source Concession Agreement with Ancestry.com Operations, Inc. for the digitization, indexing and internet publication and hosting of selected historical records.
