1 MR. STAMOULIS: All right. So, we are
2 now starting the November 7th FCRC remote
3 public hearing. My name is Alex Stamoulis.
4 I am the clerk for the FCRC. Before we get
5 started with this proceeding, I'd like to
6 confirm that everyone can hear me clearly.

7 CHAIR STODDART: Yes.

8 (Chorus of yeses.)

9 MR. STAMOULIS: Okay. All right.
10 Today's hearing is being held via Microsoft
11 Teams conference call, and we ask that all
12 attendees announce their name for the record
13 each time they speak on the call for ease of
14 transcription. If you are not speaking, we
15 once again ask that you mute your microphone
16 to avoid background noises during the call.

17 Only one person should be speaking at
18 any given time. I will direct, should there
19 be any conflict. As a reminder, we have
20 currently muted everyone on the call. If you
21 need to speak, you can unmute yourself by
22 pressing star 6 or unmuting yourself in the
23 Teams app.

24 Thank you very much.

25 Chair, we are ready to begin.

1 CHAIR STODDART: Good afternoon, and
2 thank you all for being here. My name is
3 Allison Stoddart, Chair of the FCRC. The
4 Franchise and Concession Review Committee
5 Remote Public Hearing will now come to order.

6 Will the Clerk please call the roll?

7 MR. STAMOULIS: Mayor?

1 MR. STAMOULIS: Let the record reflect

4 President, Borough of Brooklyn?

5 (No response).

6 MR. STAMOULIS: Let the record reflect
7 the president, Borough of Brooklyn is not
8 present.

9 MR. DOUGLAS: Apologies.

10 John Douglas. I'm here.

11 MR. STAMOULIS: Thank you.

12 I'm amending the record. Let the
13 record reflect the president, Borough of
14 Brooklyn is present.

15 President, Borough of Manhattan?

16 MS. VEST: Tomi Vest, present.

17 MR. STAMOULIS: President, Borough of
18 Queens?

19 MR. SWISHER: Allan Swisher for Queens
20 Borough President, Donovan Richards, present.

21 MR. STAMOULIS: President, Borough of
22 Staten Island?

23 MS. LEFKOWITZ: Lauren Lefkowitz,
24 present.

25 MR. STAMOULIS: Representative, the

1 Department of Health and Mental Hygiene?

2 MS. HELBURN: Lisa Helburn, present.

3 MR. STAMOULIS: Representative, Office
4 of Technology and Innovation?

5 MR. SIKOFF: Brett Sikoff, present.

6 MR. STAMOULIS: That concludes the roll
7 call.

8 CHAIR STODDART: This is Allison
9 Stoddart. Welcome to this remote public
10 hearing of the Franchise and Concession
11 Review Committee. The hearing being
12 conducted today has been publicly advertised
13 in accordance with the New York City Charter
14 and Concession Rules of the City of New York.

15 We want to be sure that anyone desiring
16 to be heard has an opportunity to do so. We
17 are registering individuals now for later
18 testimony. Those registered will be called
19 upon to testify after their calendar item has
20 been called. All persons wishing to speak,
21 must now provide their name, affiliation,
22 indicate which calendar items they wish to
23 testify on, and whether they are for or
24 against said item to the Clerk at this time.

25 MR. STAMOULIS: Does anyone wish to

1 testify?

2 (No response).

3 MR. STAMOULIS: It appears that no one
4 from the public wishes to testify at this
5 hearing.

6 CHAIR STODDART: Thanks.

7 Alex, do you want to just remind
8 everyone how they can unmute themselves if
9 they've called in? I just want to make sure.

10 MR. STAMOULIS: Yes. As a reminder, if
11 you've called in and you find yourself muted,
12 you can press star 6. Again, star 6 to
13 unmute yourself. If you are calling in via
14 the Teams application, you can simply unmute
15 your microphone in the application.

16 MR. GORE: I would like to testify.

17 MR. STAMOULIS: All right. Can I have
18 your name, affiliation, and which calendar
19 item, please.

20 MR. GORE: I'm Arnold Gore from
21 Brooklyn, New York. I'm a member of
22 New Yorkers for Wire Tech.

23 I'm opposed to the transfer of the
24 ZenFi Networks to a Delaware corporation.
25 There have been numerous studies

1 documenting --

2 MR. STAMOULIS: Sir, you can testify
3 when the item is called. For now, we're just
4 getting your name and affiliation, so we can
5 register you to testify later.

6 MR. GORE: Yes.

7 MR. STAMOULIS: Can I just have your
8 name one more time, please.

9 MR. GORE: Arnold Gore, A-R-N-O-L-D,
10 G-O-R-E, from Brooklyn, New York.

11 MR. STAMOULIS: Thank you very much,
12 Mr. Gore.

13 Does anyone else wish to testify?
14 Again, if you are muted, if I'm not
15 responding, press star 6 to unmute yourself.

16 (No response).

17 MR. STAMOULIS: All right. It appears
18 that no one else from the public wish to
19 testify in this hearing at this time, Madam
20 Chair.

21 CHAIR STODDART: Thank you.

22 Each speaker will be allotted
23 approximately three minutes. When you
24 testify, please restate your name and
25 affiliation, if any. You may also submit

1 written testimony to the Clerk, which will be
2 made part of the record. Any written
3 submissions must be given to the Clerk before
4 the close of the remote public hearing via
5 e-mail to fcrc@mocs.nyc.gov.

6 Will the Clerk please call the first
7 calendar item.

8 MR. STAMOULIS: New York City
9 Department of Health and Mental Hygiene,
10 Calendar Item Number 1: In the matter of the
11 intent to seek Franchise and Concession
12 Review Committee approval, pursuant to
13 Section 1-16 of the Concession Rules of the
14 City of New York, to utilize a different
15 procedure, to enter into an amendment to the
16 existing concession agreement with OptumRx
17 Discount Card Services, LLC, to develop,
18 operate and administer the NYC Drug Discount
19 Card Program available to all New York City
20 residents.

21 This amendment will extend the
22 expiration date of the concession agreement
23 from January 1, 2022, to June 30, 2023.

24 CHAIR STODDART: We will take testimony
25 from the public. But first, I'd like to ask

1 the members of the committee if they have any
2 statements?

3 (No response).

4 CHAIR STODDART: Will the Clerk please
5 call the next person who wishes to testify.

6 MR. STAMOULIS: We have heard all
7 testimony on this calendar item.

8 CHAIR STODDART: Will the Clerk please
9 call the next calendar item.

10 MR. STAMOULIS: New York City Office of
11 Technology and Innovation, Calendar Item
12 Number 2: In the matter of the intent to
13 seek Franchise and Concession Review
14 Committee approval of a proposed information
15 services franchise agreement between the City
16 of New York, by and through its Department of
17 Information Technology and
18 Telecommunications, now known as the Office
19 of Technology and Innovation, and Annex
20 Fiber, Inc., to grant a nonexclusive
21 franchise to construct, install, use, operate
22 and/or maintain wire, cable and/or optical
23 fiber and associated equipment on, over, and
24 under the inalienable property of the City
25 for the provision of Information Services.

1 The proposed franchise agreement has a
2 term lasting from notice of commencement
3 until June 26, 2032. There is an option, at
4 OTI's sole discretion, for the parties to
5 extend the agreement for up to a further
6 five-year period.

7 CHAIR STODDART: We will take testimony
8 from the public. But first, I'd like to ask
9 the members of the committee if they have any
10 statements?

11 (No response).

12 CHAIR STODDART: Will the Clerk please
13 call the next person who wishes to testify.

14 MR. STAMOULIS: We have now heard all
15 testimony on this calendar item.

16 CHAIR STODDART: Will the Clerk please
17 call the next calendar item.

18 MR. STAMOULIS: New York City Office of
19 Technology and Innovation, Calendar Item
20 Number 3: In the matter of approval --

21 MS. WILKENS: Hello?

22 MR. STAMOULIS: Yes.

23 MR. GORE: I requested to testify on
24 the transfer of the ZenFi Networks, and you
25 say that all testimony has been heard.

1 MR. STAMOULIS: Sir, that was with
2 regards -- if I may, Mr. Gore, you've
3 requested to testify on Calendar
4 Items Number 6 or 7. We are not there yet.
5 Once we get to those items, we will ask for
6 testimony and your name will be called.

7 MR. GORE: Yes. Okay. Thank you.

8 MS. WILKENS: Okay. Thank you. Thank
9 you.

10 MR. STAMOULIS: I'm sorry. I hear
11 another voice.

12 Does someone else wish to testify?

13 (No response).

14 MR. STAMOULIS: All right. From the
15 beginning, I will reintroduce Calendar Item
16 Number 3.

17 New York City Office of Technology and
18 Innovation, Calendar Item Number 3: In the
19 matter of the intent to seek Franchise and
20 Concession Review Committee approval of a
21 proposed information services franchise
22 agreement between the City of New York, by
23 and through its Office of Technology and
24 Innovations and Silicon Harlem, LLC, to grant
25 a nonexclusive franchise to construct,

1 install, use, operate and/or maintain wire,
2 cable and/or optical fiber and associated
3 equipment on, over, and under the inalienable
4 property of the City for the provision of
5 Information Services. The proposed franchise
6 agreement has a term lasting from notice of
7 commencement until June 26, 2032.

8 There is an option, at OTI's sole
9 discretion, for the parties to extend the
10 agreement for up to a further five-year
11 period.

12 CHAIR STODDART: We will take testimony
13 from the public. But first, I'd like to ask
14 the members of the committee if they have any
15 statements?

16 (No response).

17 CHAIR STODDART: Will the Clerk please
18 call the next person who wishes to testify.

19 MR. STAMOULIS: We have now heard all
20 testimony on this calendar item.

21 CHAIR STODDART: Will the Clerk please
22 call the next calendar item.

23 MR. STAMOULIS: New York City Office of
24 Technology and Innovation, Calendar Item
25 Number 4: In the matter of the intent to

1 seek Franchise and Concession Review
2 Committee approval of a proposed information
3 services franchise agreement between the City
4 of New York, by and through its Office of
5 Technology and Innovation and United Federal
6 Data of New York, LLC, to grant a
7 nonexclusive franchise to construct, install,
8 use, operate and/or maintain wire, cable
9 and/or optical fiber and associated equipment
10 on, over, and under the inalienable property
11 of the City for the provision of Information
12 Services.

13 The proposed franchise agreement has a
14 term lasting from notice of commencement
15 until June 26, 2032. There is an option, at
16 OTI's sole discretion, for the parties to
17 extend the agreement for up to a further
18 five-year period.

19 CHAIR STODDART: We will take testimony
20 from the public. But first, I'd like to ask
21 the members of the committee if they have any

5 MR. STAMOULIS: New York City Office of
6 Technology and Innovation, Calendar Item
7 Number 5: In the matter of the intent to
8 seek Franchise and Concession Review
9 Committee approval of a proposed information
10 services franchise agreement between the City
11 of New York, by through its Office of
12 Technology and Innovation and Virtual Media
13 Visions Network, LLC, to grant a nonexclusive
14 franchise to construct, install, use, operate
15 and/or maintain wire, cable and/or optical
16 fiber and associated equipment on, over, and
17 under the inalienable property of the City
18 for the provision of Information Services.

19 The proposed franchise agreement has a
20 term lasting from notice of commencement
21 until June 26, 2032. There is an option, at
22 OTI's sole discretion, for the parties to
23 extend the agreement for up to a further
24 five-year period.

25 CHAIR STODDART: We will take testimony

1 from the public. But first, I'd like to ask
2 the members of the committee if they have any
3 statements?

4 (No response).

5 CHAIR STODDART: Will the Clerk please
6 call the next person who wishes to testify.

7 MR. STAMOULIS: We have now heard all
8 testimony on this calendar item.

9 CHAIR STODDART: Will the Clerk please
10 call the next calendar item.

11 MR. STAMOULIS: New York City Office of
12 Technology and Innovation, Calendar Item
13 Number 6: In the matter of the intent to
14 seek Franchise and Concession Review
15 Committee approval of a proposed acquisition
16 of ZenFi Networks, LLC, in its entirety, by
17 BAI U.S. HoldCo, LLC.

18 ZenFi Networks, LLC is the holder of an
19 information services franchise agreement with
20 City of New York, which grants a nonexclusive
21 franchise to construct, install, use, operate
22 and/or maintain wire, cable and/or optical
23 fiber and associated equipment on, over, and
24 under the inalienable property of the City
25 for provision of Informational Services.

1 OTI has reviewed the proposed
2 transaction and the franchise agreement and
3 has determined that FCRC approval is
4 required.

5 CHAIR STODDART: We will take testimony
6 from the public. But first, I'd like to ask
7 members of the committee if they have any
8 statements?

9 (No response).

10 CHAIR STODDART: Will the Clerk please
11 call the next person who wishes to testify.

12 MR. STAMOULIS: Arnold Gore, please
13 provide your full name and affiliation for
14 the record.

15 MR. GORE: I am Arnold Gore from
16 Brooklyn, New York, and I'm with New Yorkers
17 for Wire Technology.

18 I'm opposed to the transfer of ZenFi
19 Networks to a Delaware corporation. There
20 have been numerous studies documenting the
21 increased brain cancer rates and decreased
22 fertility rates associated with wireless
23 communications. See Environmental Health
24 Trust. Their website is ehtrust.org/science.

25 And insurance companies will not ensure

1 the safety of wireless networks because it's
2 too unknown at the extent of damage. And
3 this just adds an additional layer of denial
4 of liability protection. The District of
5 Columbia Circuit Court of Appeals, which is
6 one rung below the United States Supreme
7 Court, had ordered the federal communications
8 commission to update its 25-year-old
9 standards on the wireless exposure.

10 With their decision of August 13, 19 --
11 2021, to date, the FCC has not updated those
12 regulations. We should not be considering
13 Wi-Fi until they have updated those
14 regulations. In over a year, they have not
15 done that. We should be able to influence
16 kind of technology used. Wire technology is
17 much superior.

18 Thank you.

19 MR. STAMOULIS: Thank you for your
20 testimony, Mr. Gore.

21 Before we close off testimony on this
22 item, I believe I heard one other individual
23 express interest. If you wish to speak on
24 this item, please --

25 MS. WILKENS: Yes.

1 MR. STAMOULIS: -- identify yourself.

2 MS. WILKENS: Yes. Can you hear me?

3 MR. STAMOULIS: Yes. Can you please
4 provide your full name and affiliation for
5 the record.

6 MS. WILKENS: Yes. Odette Wilkens, and
7 I am president and general counsel of Wired
8 Broadband, Inc., based in Forest Hills, New
9 York.

10 MR. STAMOULIS: Okay. You have
11 three minutes to testify. You may proceed
12 now.

13 Thank you.

14 MS. WILKENS: Okay. Thank you.

15 I'm an attorney. Having represented
16 many multinational corporations and
17 technology transaction over the past
18 20 years, I just want to say that these jumbo
19 5G monopoles that's now being erected around
20 the City, in Borough Park, Lower East Side,
21 Upper East Side and Upper West Side. The
22 residents of these locations are outraged by
23 these structures in the neighborhoods right
24 outside their window.

25 And, in fact, in one instance, it is

1 less than ten feet from the building, which
2 under the franchise agreement requires input
3 and approval of a community board. That has
4 not happened. There's also a resident with a
5 pacemaker who should no be anywhere near such
6 tower. It's literally the Wild West in New
7 York City, as far as wireless installations
8 are concerned.

9 The committee should not be allowing
10 these monstrosities on our street and
11 endangering the health of our residents.
12 There are thousands of scientific Syracuse
13 studies concluding biological harms and,
14 indeed, people have been seriously injured in
15 New York City, and some have had to take
16 refuge outside of New York City because of
17 the radiation already emitted by existing
18 structures.

19 These jumbo 5G monopoles will make it
20 worse. Now, there are several issues to take
21 into consideration; one is, there has been no
22 transparency in the process. The franchise
23 and agreement that I believe this committee
24 approved for telecom structures were approved
25 in April of 2020 in the middle of lockdown.

1 There was no transparency, no public hearings
2 regarding any of these 5G antenna
3 installations or the significance of these
4 franchising agreements.

5 The FCC emission limits are outdated,
6 as Mr. Gore indicated. The Court of Appeals
7 of the DC Circuit in 2021 discredited the
8 FCC's wireless emission standards, which are
9 outdated as of 1996 because the FCC failed to
10 take into consideration the submissions of
11 11,000 pages of scientific study. Now, there
12 has been no environmental review. Absolutely
13 none.

14 MR. STAMOULIS: One minute remaining.

15 MS. WILKENS: Thank you.

16 Of any environmental impact or health
17 impact on the residents of New York City. I
18 would not approve of any additional
19 franchising opportunities or such with ZenFi.
20 And I'm -- I'm sorry. What did you say?

21 MR. STAMOULIS: I apologize. I
22 mistakenly assumed you were finish. If you
23 have further testimony, you may continue.

24 MS. WILKENS: Okay. I'm sorry.

25 We submitted FOILS to the Department of

1 Information Technology and Telecommunications
2 as early as October and November of last year
3 for information regarding these jumbo 5G
4 monopoles, and they included the proposed
5 locations of each of these towers, all
6 electrical and engineering drawings
7 specifications, wavelength, frequency,
8 antenna gain, antenna length, power potential
9 of the wireless antennas, model number, the
10 companies will be manufacturing and
11 installing them, and all FCC frequency band
12 in which these wireless antennas will be
13 operating, and as well as any correspondence
14 between the City and ZenFi, and none has been
15 forthcoming.

16 The DoITT has an extent in the time to
17 respond, about every 30 days. It is now over
18 a year and --

19 MR. STAMOULIS: That completed your
20 time. Thank you so much for your testimony.

21 MS. WILKENS: Thank you.

22 MR. STAMOULIS: Thank you.

23 Does anyone else wish to speak on this
24 calendar item?

25 (No response).

1 MR. STAMOULIS: We have now heard all
2 testimony on this calendar item.

3 CHAIR STODDART: Will the Clerk please
4 call the next calendar item.

5 MR. STAMOULIS: New York City Office of
6 Technology and Innovation, Calendar Item
7 Number 7: In the matter of the intent to
8 seek Franchise and Concession Review
9 Committee approval of a proposed acqui --
10 (speaking interruption).

11 I apologize. Could whoever is speaking
12 please mute themselves.

13 I will restart from the beginning.

14 New York City Office of Technology and
15 Innovation, Calendar Item Number 7: In the
16 matter of the intent to seek Franchise and
17 Concession Review Committee approval of a
18 proposed acquisition of ZenFi Networks, LLC
19 by BAI U.S. HoldCo, LLC.

20 ZenFi Networks, LLC is the holder of a
21 mobile telecom franchise agreement with the
22 City of New York allowing the installation,
23 operation, maintenance of equipment and
24 facilities, including base stations and
25 access point facilities on New York

1 City-owned street lights and traffic
2 lights -- light poles, and certain
3 privately-owned utility poles located on the
4 City streets.

5 And subject to further necessary
6 approvals, LinkNYC kiosks, bus stops
7 shelters, and automatic public toilets, all
8 in connection with the provision of mobile
9 telecommunications services.

10 OTI has reviewed the proposed
11 transaction and the franchise agreement and
12 has determined that FCRC approval is
13 required.

14 CHAIR STODDART: We will take testimony
15 from the public. But first, I'd like to ask
16 the members of the committee if they have any
17 statements?

18 (No response).

19 CHAIR STODDART: Will the Clerk please
20 call the next person who wishes to testify.

21 MR. STAMOULIS: Mr. Arnold Gore, you
22 indicated you wish to testify regarding the
23 ZenFi Networks, LLC matter. Do you wish to
24 testify on this item?

25 MR. GORE: (Inaudible).

1 MR. STAMOULIS: I'm sorry. Could you
2 repeat, Mr. Gore.

3 MR. GORE: This is Arnold Gore
4 speaking. I previously testified on the
5 ZenFi Networks that transferred to the
6 Delaware -- for a Delaware corporation to
7 take over that network.

8 Is this -- am I going to root, also,
9 regarding that transfer?

10 MR. STAMOULIS: There are two
11 agreements being transferred, Mr. Gore;
12 Calendar Items Number 6 and Calendar Items
13 Number 7. You have testified on Calendar
14 Item Number 6.

15 Do you wish to testify on Calendar Item
16 Number 7?

17 MR. GORE: I would want the same
18 testimony to apply to that.

19 MR. STAMOULIS: All right. I will make
20 sure the record reflects that.

21 MR. GORE: Okay. Thank you.

22 MR. STAMOULIS: All right. Ms. Odette
23 Wilkens, do you wish to testify on Calendar
24 Item Number 7?

25 MS. WILKENS: Yes. I think just as

1 Mr. Gore indicated, I would like to have my
2 testimony from number 6 also reflected in
3 number 7, but I do have some more information
4 to include.

5 MR. STAMOULIS: Okay. You may begin
6 when ready. As a reminder, you have
7 three minutes to testify.

8 MS. WILKENS: Okay. Thank you.

9 I just wanted to also say that many
10 local government (inaudible) by the FCC to
11 install these 5G towers. That is false. The
12 Telecommunications Act of 1996 has given
13 local government the explicit authority on
14 the number and placement of cell towers.

15 In July of this year, senior federal
16 judge in the Eastern District of New York
17 underscored that point and issued a sweeping
18 decision, which stated that the FCC's 5G
19 order in trying to strip local government of
20 its control over regulating the placement of
21 towers is not binding within the New York
22 jurisdiction.

23 And wireless carriers have the burden
24 of showing that there is a gap in cell
25 service and that they are using the least

1 intrusive means possible to fill gap. Right
2 now, with these 5G monstrosities that are
3 being placed all around New York City, this
4 is not the least intrusive. It is the most
5 intrusive means possible. And 5G is not
6 about cell phone service. It's about big
7 data transfer.

8 Big data transfer and streaming videos
9 may be fine, you know, generally, but it's
10 not preempted by the TCA. And so, as a
11 federal judge in the Eastern District of New
12 York clarified, improved capacity and speed
13 are desirable and no doubt profitable, but
14 they are not protected by the
15 Telecommunications Act.

16 Now, in fact, I have to say that I have
17 been injured by this wireless radiation.
18 There were a set of rooftop antennas that
19 were placed on top of buildings in the
20 neighborhood where I live, and I woke up one
21 morning with heart palpitations and I've had
22 some balance issues. I'm otherwise in
23 excellent health with no underlying
24 conditions. These issues occur only when I'm
25 exposed to wireless radiation. And that also

1 includes the kiosks.

2 These and rogue installations done
3 without the informed consent of our residents
4 and which are not preempted or protected by
5 the Telecommunications Act. And there's an
6 unfortunate irony here that wireless
7 infrastructure has been funded by public
8 money, yet it's being deployed without the
9 public's awareness or consent. And despite
10 the public --

11 MR. STAMOULIS: One minute remaining.

12 MS. WILKENS: -- deployment.

13 Is that it? I'm sorry. What did you
14 say?

15 MR. STAMOULIS: You have a little less
16 than one minute remaining.

17 MS. WILKENS: Oh, okay. Okay. Great.

18 And so, the alternative to wireless is
19 fiber to the premises. Wireless, including
20 5G, depends on fiber. So, wireless is
21 actually an inferior service which cannot
22 provide anywhere near the speed capacity or
23 established security the fiber optics can,
24 and we should really be going with wired
25 solutions, not continued wireless solutions.

1 Thank you very much.

2 MR. STAMOULIS: Thank you for your
3 testimony.

4 We have now heard all testimony on this
5 item.

6 CHAIR STODDART: Thank you.

7 Before we conclude, I want to ask if
8 any of the agencies presenting calendar items
9 today have any statements for the record,
