NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 1: **IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval pursuant to Section 1-16 of the Concession Rules of the City of New York, to utilize a different procedure, to enter into a concession agreement with Row New York Inc., for the use, maintenance, and operation of rowing facilities at Sherman Creek, Manhattan, for a twenty (20) year term.

RESULT: Resolution Adopted (6-0) (On behalf of the Borough Presidents, vote cast by Manhattan Borough President).

NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 2: **IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval pursuant to Section 1-16 of the Concession Rules of the City of New York, to utilize a different procedure to negotiate a sole source license agreement with City Parks Foundation for the sale of naming rights of the SummerStage festival, primarily based in Central Park, Manhattan, and the operation and maintenance of a food, beverage, and merchandise concession related to the presentation of live events at SummerStage in Central Park, Manhattan.

RESULT: Resolution Adopted (6-0) (On behalf of the Borough Presidents, vote cast by Manhattan Borough President).

NEW YORK CITY DEPARTMENT OF SMALL BUSINESS SERVICES

No. 3: **IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval pursuant to Section 1-16 of the Concession Rules of the City of New York, to utilize a different procedure, to negotiate a non-exclusive, Sole Source License Agreement with Fair Harbor Clothing PBC for the non-exclusive use of city-owned trademarks on merchandise.
