6. ***requirements of the City Administrative Procedure Act also known***

7. ***as CAPA.***

8. ***The purpose of this hearing is to receive comments from the public***

9. ***on OATH's Proposed Rule to amend the table of violations in***

10. ***Chapter 7-02(a) of Title 48 of the Rules of the City of New York***

11. ***in order to add 56 RCNY Section 1-04(c)(5) and 56 RCNY Section***

12. ***1-04(i)(4) to the table of violations eligible for community service.***

13. ***The Office of Administrative Trials and Hearings proposes to***

14. ***amend the table of violations in Chapter 7-02(a) of Title 48 of the***

15. ***Rules of the City of New York. This amendment will add 56***

16. ***RCNY 1-04(c)(5) and 56 RCNY 1-04(i)(4) to the table of violations***

17. ***eligible for community service in lieu of paying a civil monetary***

18. ***penalty if the Respondent admits to the specified violation alleged in***

19. ***a summons before a hearing date, or if the specified violation is***

20. ***sustained after a hearing.***

21. ***OATH's authority for this rule is found in Section 1049(4)(g) of the***

22. ***City Charter.***

23. ***The proposed rule was published in The City Record on***

24. September 10, 2025. OATH e-mailed the rule to the Speaker of
25. the City Council; every member of the City Council; all community
26. board managers; the news media; as well as civic organizations.
27. In addition, OATH posted the proposed rule on OATH's website; the
28. New York City Rules website, and The City Record online website.
29. OATH has been accepting written comments on the proposed rule
30. since the date it was published in The City Record and will
31. continue to accept written comments through the close of business
32. today.

33. At this hearing, you may present an oral statement concerning
34. the proposed rule. Before you begin:

35. Please state your name and affiliation whether you are with an
36. agency, the media, etc.

37. Please speak slowly and clearly, so that your statement can be
38. accurately recorded. Please limit your statement to no more than
39. three minutes.

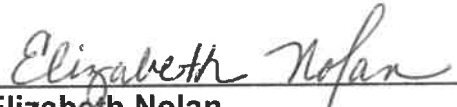
40. Shortly after today's hearing, copies of all written comments
