Specifications for Removal or Deactivation of Structures

1. Structures on or above a mapped street

A. Complete removal of structure(s) and restoration of all New York City property disturbed by removal is required (including on the outside of lines occupied by the structure(s)).

2. Structures under a mapped street

A. The roadway shall not be opened to remove the structure. This would disrupt both pedestrian and vehicular traffic.

B. Internal conduits within a tunnel shall be removed, if possible. If this is not possible, they must be cut at both ends of the tunnel

C. All void space in a tunnel or pipe over 4 inches in diameter shall be hydraulically filled with sand. If the pipe is too small to permit this, the engineer may request that this requirement be waived stating the supporting facts.

D. The tunnel or pipe shall be permanently plugged and capped at both ends where it enters private property.

3. Permits, plans, filing

A. Work shall not proceed until necessary approvals have been obtained from all agencies having jurisdiction.

B. Upon completion of the deactivation or removal, written certification, signed and sealed by a P.E. must be received by: Director, Revocable Consents, 55 Water Street, 9th Floor South, New York, NY 10041.
